Libraries in Florida." The committee will meet again soon to discuss next steps.

Sandy attended the last FLA Conference meeting which fell on the same day as our last FACRL Board meeting. It went well. She learned that FLA is happy to have us on board and that everyone is excited to be a part of this opportunity. At that time, we only had secured one room but Renaine luckily got us another one for use of our break out sessions.
